The purpose of this All County Welfare Director's Letter is to provide counties with the current Pickle Tickler Type 52 NOA address database and to request updates. Pursuant to *Lynch v. Rank* lawsuit, the Pickle Tickler Type 52 NOA letter is mailed annually to the home address of individuals, who currently receive Title II Retirement, Survivor's, and Disability Insurance payments and were determined ineligible for the Pickle Program, immediately following discontinuance from Supplemental Security Income/State Supplemental Payment.

In December of each year, the Department of Health Care Services mails the Type 52 NOA letters. The county contact information listed on the bottom of the NOA letter aids potential Pickle Program eligible individuals requesting county assistance to apply for the Pickle Program.
