## HOSPITAL SERVICES FOR MEDI-CAL BENEFICIARIES

This letter provides a listing of additional areas where contracting has been implemented to provide inpatient hospital care for Medi-Cal beneficiaries. This updates the list you received in the March 11 All County Welfare Directors Letter 83-20.

The list classifies hospitals within Health Facility Planning Areas (HFPA) by contracting, non-contracting and exempt and other hospitals such as psychiatric only hospitals. The additional HFPA's are San Fernando, Van Nuys, Burbank, Glendale, Pasadena, West San Gabriel, East San Gabriel, Pomona, Whittier, Downey/Norwalk, South Los Angeles (Watts), La Canada, North San Diego County, Los Angeles, and West Los Angeles.

The State has not contracted through the selective hospital contracting process for the provision of acute psychiatric care in these areas. Therefore, all beneficiaries who reside in these HFPA's may continue to obtain those services from any approved Medi-Cal provider.
